

**SUPPLEMENT NO. 1
TO INVESTOR PACKAGE**

Up to \$200,000 Worth of Series A Membership Units

This Supplement No. 1 to the Investor Package (the “Supplement”) supplements and amends and should be read with the Investor Package dated July 21, 2017 (the “Investor Package”) relating to the offering (the “Offering”) by Rustech Brewing Company, LLC, a Minnesota limited liability company (“we,” “us” and the “Company”), of up to \$200,000 worth of Series A Membership Units (the “Units”) at an offering price equal to \$1.00 per Unit. This Supplement is being provided to investors to inform them of recent events that have occurred since the date of the Investor Package.

An investment in the Units is highly speculative, involves a high degree of risk and is suitable only for investors with substantial means who can bear the economic risk of the investment for an indefinite period of time, have no need for liquidity of the investment and have adequate means of providing for their needs and contingencies. An investment in the Units should be made only by persons able to bear the risk in the event the investment results in a total loss.

In addition to this Supplement, each investor should carefully read the Investor Package, including, but not limited to, the information set forth in the Investor Package under the Section entitled “Risk Factors.” The Investor Package contains more detailed information about the Company, its business and financial condition and the Units.

In making an investment decision, investors must rely on their own examination of the Company and the terms of the Offering, including the merits and risks involved. The Units have not been recommended by any federal or state securities commission or regulatory authority. Furthermore, the foregoing authorities have not confirmed the accuracy or determined the adequacy of the Investor Package or this Supplement. Any representation to the contrary is a criminal offense.

All capitalized terms used but not defined in this Supplement have the definitions ascribed to them in the Investor Package. Except as otherwise expressly amended by this Supplement, the Investor Package remains in full force and effect.

RECENT EVENTS

Misstatements

1. Due to a mathematical error within the Summary of Terms, the Offering mistakenly stated that investors will be purchasing “up to 39%” of the Company’s Membership Units. Any and all references to the total amount of investors’ ownership, upon sale of all \$200,000 worth of Series A Units should instead be “up to 31%.”
2. The Offering mistakenly referred investors to “sppx.com.” Any and all references to the investment portal should instead be “sppx.io.”

Investment Amount

1. In order to attract more investors, the Company has modified its minimum investment for each individual investor to \$1,000.

Investment Perks

2. In order to attract more investors, the Company has modified its perk program to include the following beverages for each individual investment tier:
 - a. \$1,000: The first free pint for life
 - b. \$2,500: The first free pint for life + (1) growler per month
 - c. \$5,000: Two free pints each visit + (1) growler per month
 - d. \$7,500: Two free pints each visit + (2) growlers per month
 - e. \$10,000: Two free pints each visit + (2) growlers per month + a seasonal beer named after the investor
